1.0 OPERATING HOURS

XWORK SOLUTION SDN BHD hereinafter referred as XWORK will provide the stipulated service during business hours from 9:00 am to 7:00pm Monday to Friday and XWORK will adhere to any public holidays in accordance with the Malaysian law for the state of Kuala Lumpur, Malaysia. XWORK may also declare certain business day as off day(s) provided that if XWORK were to give prior notice of at least 5 working days in advance.

1.1 COMMUNICATIONS

XWORK primary communication channel shall be via email and emails sent through XWORK Corporate Email Server to the email address provided by the Client on the registration form shall be deem as delivered, accepted and understood from the time it is sent. It is the Client's responsibility to update XWORK with his/her latest working email address in the event of any changes differing from that stipulated in the registration form.

1.2 SALES AGREEMENT
